- 1. Article III, Section 3.19 is hereby deleted, and the following replaced in lieu thereof:
- "3.19. <u>Management</u>. The Association may, but shall not be required to, employ a professional management agent or agents at compensation established by the Board to perform such duties and services as the Board shall authorize. The Board may delegate to the management agent such powers as are necessary to perform its assigned duties; provided, the Board may not delegate policy-making authority.

No remuneration shall be accepted by the management agent from vendors, independent contractors, or others providing goods or services to the Association, whether in the form of commissions, finder's fees, service fees, prizes, gifts, or otherwise; anything of value shall benefit the Association. In addition, any financial or other interest which the management agent may have in any firm providing goods or services to the Association shall be disclosed promptly to the Board."

2. Except as expressly modified by this Amendment, all other terms and provisions of the Bylaws remain unmodified and are in full force and effect.

The foregoing was adopted as amendments to the By-Laws of THE ARBORS HOMEOWNERS ASSOCIATION OF BREVARD COUNTY, INC., a corporation not for profit under the laws of the State of Florida, on this 16<sup>th</sup> day of December, 2021.
