CERTIFICATE OF AMENDMENT TO DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS FOR VENTANA

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, as President and Secretary of VENTANA OWNERS ASSOCIATION, INC. (hereinafter "Association"), pursuant to the Florida Statutes and the DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS FOR VENTANA, recorded in Official Records Book 3461, Page 1665, of the Public Records of Brevard County, Florida, as amended (hereinafter "Declaration"), hereby certify that the AMENDMENT TO DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS FOR VENTANA, which amendment is attached hereto and by reference made a part hereof (hereinafter "Amendment"), was duly adopted in accordance with the requirements of the Declaration.

Pursuant to Article XIII, Section 13.2 of the Declaration, such requisite affirmative written consent of not less than seventy-five (75%) percent of the total voting power of the members of the Association has, in fact, been acquired prior to the recordation of such amending instrument among the Public Records of Brevard County, Florida.

The Association is a homeowners association created pursuant to the laws of the State of Florida. With the exception of the attached Amendment, all other terms and conditions of the Declaration shall remain in full force and effect.

AMENDMENT TO DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS FOR VENTANA

The following amendment is made to Article VI, Section 6.2 of the DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS FOR VENTANA, recorded in Official Records Book 3461, Page 1665, et. seq., of the Public Records of Brevard County, Florida (additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>, and omitted but unaltered provisions are indicated by ellipses):

ARTICLE VI

<u>USE RESTRICTIONS - RESIDENTIAL PROPERTY</u>

The use, occupation, and enjoyment of any LOT shall be subject to and governed by the following covenants, conditions, and restrictions, to wit:

6.2 Ownership and Leasing. Ownership of any LOT shall be for single family residential dwelling purposes only. Accordingly, RESIDENTIAL PROPERTIES may not be rented or leased for any single period of less than one twelve (12) months. No "Time Sharing Plan" as that term is defined in Section 721.05 Florida Statutes, or any similar plan of fragmented or interval ownership of any LOT shall be permitted.
